

Netflix Promotion Terms and Conditions

1. The How to Claim instructions form part of these Terms and Conditions. By entering the Netflix Promotion (the “Promotion”), participants agree to be bound by these Terms and Conditions.
2. The Promotion is promoted by Telkom SA (the “Promoter”).
3. This Promotion cannot be redeemed in conjunction with any other promotion.
4. Participants must subscribe to a qualifying Telkom service the start of the promotion, a list of qualifying Telkom products for this promotion can be found at www.telkom.co.za.
5. Access to a computer or other device that streams from Netflix (manufactured and sold separately) and broadband internet connection are required in order to benefit from the Promotion and to watch instantly. Further details on these requirements can be found at www.netflix.com/TermsOfUse.
6. A qualifying participant shall receive a 3-month subscription of Netflix Standard plan, which is worth R417. The plan offers unlimited TV shows and movies from Netflix on two devices at a time in High Definition (HD). This plan also lets you download titles to phones or tablets.
7. Participants must redeem the voucher on the www.telkom.co.za. New subscribers must sign up to Netflix.
8. Customers can cancel their subscription renewing at any time. For details please visit www.netflix.com/TermsOfUse.
9. For the existing subscribers, the voucher value R417.00 will be added to your account once the voucher code is redeemed. Customers can switch to other plans at www.netflix.com/changeplan.
10. The Netflix voucher codes must be redeemed by 30 September 2019.
11. The Promotion is only open to legal residents of South Africa aged 18 or over.
12. Only one voucher code per Netflix account can be redeemed for this promotion. Multiple qualifying Telkom products does not entitle the end-user to “stack” Netflix vouchers on a single account.
13. If participants return their qualifying Telkom products after purchase, the redeemed Netflix voucher will be voided so that customers don’t have to return anything for the Netflix voucher.
14. The remainder of the Netflix 3-month subscription shall be lost if the subscriber cancels the Netflix subscription before the expiry of the relevant period. No refund shall be provided. This does not affect a participant’s statutory rights.
