

Showmax Promotion Terms and Conditions

1. The How to Claim instructions form part of these Terms and Conditions. By entering into the Showmax Promotion (the "Promotion"), participants agree to be bound by these Terms and Conditions.
2. The Promotion is promoted by Telkom SA (the "Promoter").
3. This Promotion cannot be redeemed in conjunction with any other promotion.
4. Participants must have an active qualifying Telkom service at the start of the promotion to qualify for the promotion. Telkom can at any time add to and remove from the list of qualifying products and/or customers for the promotion.
5. Access to a computer or other device that streams from Showmax (manufactured and sold separately) and broadband internet connection are required in order to benefit from the Promotion and to watch instantly.
