



## **#TelkomBlackFriday - Terms & Conditions**

### **November 2020**

#### **1. Competition Rules:**

- 1.1 This promotional competition ("Competition") is organised and run by Telkom SA SOC Ltd (Registration Number 1991/005476/30), a listed company duly registered in accordance with the laws of the Republic of South Africa, with its registered address at Telkom Park the Hub, 61 Oak Avenue, Techno Park Highveld Centurion, Pretoria("Telkom") including its affiliates, partners, associations and agents ("Organizers").
- 1.2 By entering this Competition all participants agree to abide by the following competition rules:

#### **2. Competition Period:**

- 2.1 The Competition commences on 16 November 2020 from 10:00am and will continue until 29 November 2020 at 23:59.
- 2.2 The duration of the Competition may be extended or curtailed at the discretion of the Organizer. Any such amendment will be communicated via Telkom's social media platforms.

#### **3. Who is eligible to win a prize:**

- 3.1 Persons ("Participants") interested in entering the Competition must:
  - 3.1.1 be a natural person;
  - 3.1.2 be a South African citizen or a permanent resident with a valid identity document or passport and reside in South Africa;
  - 3.1.3 be 18 (eighteen) years old or older and
  - 3.1.4 have participated in the Competition as per clause 4 below during the Competition Period
- 3.2 Employees of the Telkom Group and their immediate families, advertising and promotion agencies, distribution partners, associated companies, and outlet owners and their immediate families and staff associated with this Competition are not allowed to enter the Competition.

## 4. To participate:

4.1 To enter the Competition and to be considered for a Day-to-day data prize, participants need to engage with Telkom on its Social Media pages as described in the social media post relating to that day's #TelkomBlackFriday content post.

4.2 Participants must use the hashtag #TelkomBlackFriday to be considered for a Day-to-day data prize.

4.3 To enter the Competition and to be considered for the General Prizes, participants must register with their name, email or phone number on the Telkom website. Each unique registration contributes 250MB to the 1 Terabyte data pool – which will be reflected in real time on the website. The General Prizes will only be awarded after the competition period has ended.

4.4 To enter the Competition and to be considered for the Grand Prize, participants must search for the daily clue and puzzle content posts across our Twitter, Facebook and Instagram social media channels, and then use that keyword when registering with their name, email or phone number on the website, which will also add an additional 250MB to the 1 Terabyte data pool.

4.4.1 The Grand Prize data pool, made up by individual unique registrations (250MB per registration) and use of keywords (250MB per keyword), will contribute towards the total of and not exceed 1 Terabyte in data value.
