

NGN Voice Product Competition

Terms and conditions

[Competition period: 20 January 2021 – 20 April 2021]

1. This promotional Competition is organised by Telkom. The Competition is open for entry by all South African residents aged 18 years and older, with a valid South African identity document.
2. The Competition is not open to any employee, director, member, partner, agent, consultant or any person directly or indirectly who controls or is controlled by Telkom and/or immediate family members of any the aforementioned individuals, or, their advertising agencies, advisers, dealers, its affiliates and/or associated companies (“Disqualified Persons”).
3. By entering the Competition, all participants agree to be bound by these terms and conditions, which will be interpreted by Telkom.
4. Telkom’s decision regarding any issue, related to this Competition will be final and binding and no correspondence will be entered into. Telkom reserve the right to amend, modify, change, postpone, suspend or cancel this Competition and any prizes related to the Competition, (which have not yet been subject to a draw), or any aspect thereof, without notice at any time, for any reason which the Organizers reasonably deem necessary.
5. The Competition commences on 20 January 2021 and will run until 20 April 2021, both days inclusive.

 - a) To qualify, the customer must:
