

## Netflix Promotion Terms and Conditions

1. The How to Claim instructions form part of these Terms and Conditions. By entering the Netflix Promotion (the “Promotion”), participants agree to be bound by these Terms and Conditions.
2. The Promotion is being offered by Telkom SA (the “Promoter”).
3. This Promotion cannot be redeemed in conjunction with any other promotion that Telkom may be running currently.
4. Participants must subscribe to a qualifying Telkom service from the start of the promotion, a list of qualifying Telkom products for this promotion can be found at this link: [www.telkom.co.za](http://www.telkom.co.za)

Access to a computer and/ or other device that streams from Netflix (manufactured and sold separately) and broadband internet connection are required in order to benefit from the Promotion and to watch instantly. 10. For existing Netflix subscribers, the voucher value R417.00 credit will be added to your Netflix account once the voucher code is redeemed. Customers can switch to other plans at [www.netflix.com/changeplan](http://www.netflix.com/changeplan).
11. The Netflix voucher codes must be redeemed by 30 September 2019.
12. The Promotion is only open to South African residents aged 18 years or older.
13. Only one voucher code per Netflix account can be redeemed for this promotion. Multiple qualifying Telkom products does not entitle the end-user to “stack” Netflix vouchers on a single account.
