- 1) Telkom is pleased to announce the “Tour de fast” online competition in support of our 947 sponsorship.

- 2) Selection of winners:

- a) The top 5 Tour de Fast scores by the closing time of 20 November 23:59 will be selected as the winners.
- b) Winners will be selected after the 20<sup>th</sup> of November 23:59 closing of the competitions and be done according to Telkom auditing regulations.
- c) The winners will be notified via email on or before 4 December 2016 and must provide an address for delivery (for the first-place winner only) to claim their prizes.
- d) If a winner does not respond to Telkom within 14 days of being notified of their win, the winner's prize will be forfeited and another winner will be chosen, following the same process stated above.

## 3) ENTRY REQUIREMENTS

### 3.1 How to enter

- To enter the competition you must play the game, score as many points as possible, and submit your personal details, alongside your score, at the end of a game.

### **3.3 Who is not eligible to enter?**

- Telkom employees and associated family and friends
- Telkom vendors and customer partners
- Minors under the age of 18

### **3.4 What are the selection criteria's?**
